1. Introduction

Our website, <https://www.lonestarvalorfunding.com> (hereinafter: “the website”) uses cookies and other related technologies (for convenience all technologies are referred to as “cookies”). Cookies are also placed by third parties we have engaged. In the document below we inform you about the use of cookies on our website.

2. Selling data to third parties

Our privacy statement describes the limited circumstances under which we share or sell personal information to third parties and if we use or disclose sensitive personal information. You may request that we exclude your personal information from such arrangements, or direct us to limit the use and disclosure of possible sensitive personal information, by entering your name and email address below. You may need to provide additional identifying information before we can process your request.

2.1 Categories of data

3. Cookies

When you visit our website it can be necessary to store and/or read certain data from your device by using technologies such as cookies.

3.1 Technical or functional cookies

Some cookies ensure that certain parts of the website work properly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. 3.2 Statistics cookies

3.3 Advertising cookies

On this website we use advertising cookies, enabling us to personalize the advertisements for you, and we (and third parties) gain insights into the campaign results. This happens based on a profile we create based on your click and surfing on and outside <https://www.lonestarvalorfunding.co>. With these cookies you, as website visitors are linked to a unique ID, so you do not see the same ad more than once for example.

You can object to the tracking by these cookies by clicking the “Manage Consent” button.

3.4 Marketing/Tracking cookies

Marketing/Tracking cookies are cookies or any other form of local storage, used to create user profiles to display advertising or to track the user on this website or across several websites for similar marketing purposes.

3.5 Social media
